4. That I know I have the right to a trial by jury, to subpoena witnesses in my behalf, and to confront my accusers; I hereby knowingly and intelligently waive these rights;
5. That I am entering the aforementioned plea of my own free will and that nobody has made any threat or used any force or pressure of any kind or made any promises to me to make me plead as I have done so herein;
6. That I am mentally competent and sober at the time that I sign the Waiver and Plea, and fully understand what I am doing;
7. That I understand that the Judge will find me guilty of the offense of Speeding, 14 mph over the posted speed limit. I hereby consent to the Judge doing this without my being physically present when he does so.
